2. PROJECT PROGRESS

(a) Progress in Implementation

(describe the progress and, if applicable, highlight any problems or challenges that could endanger completion of the project)

In the original document approved by 23rd Meeting of ASEAN Sectoral Working Group on Crops the 3 major activities proposed, i.e. Training Workshop (TW) on Begomovirus & LAMP PCR was scheduled to be implemented in July 2019, TW on Plant Parasitic Nematodes in October 2019 and the 2 months Attachment Program in December 2019 and January 2020. However, the proposal was only approved by the Government of Japan on 15th July 2019 for one year until 14th July 2020. Subsequently, the project disbursement letter dated 27th August was received and based on these emails to the Japanese Resource persons were sent on 5th September informing that the project has been approved and requested them on their availability to implement the agreed activities.

Prof. Hideaki Iwahori from Ryukoku University agreed to be our resource person in the training workshop on "Plant Parasitic Nematodes" for 2 weeks to be held in Indonesia and attachment program on the same topic (for 2 months) in his laboratory. However, he has replied indicating that until February 2020 he will be very busy with the supervision of his graduate students and also his own research program. Therefore, he has requested that the training workshop be held sometime in February 2020 and for the attachment program about 3 months after the training, i.e. in June/July 2020 (Attachment 1)

Prof. Masashi Ugaki from Tokyo University has also agreed to be our Japanese resource person in the 2-weeks training workshop on "Begomovirus and LAMP-PCR" to be held in the Philippines. However, he informed us that until March 2020, he will be the Head of Department of Integrated Biosciences, and as the Head it will not be easy for him to take leave from the university for two weeks. Therefore, he has requested that the workshop should be held sometime in June or July, 2020 (Attachment 2).

In relation to the above changes, therefore, we have sent letters to all members of the Phase 2 Project Steering Committee, with a draft revision of the Work Plan (see Attachment 3 & 4) for their consideration and approval. The revised Work Plan has been approved by all members of the Project Steering Committee.

(b) Progress towards Achievement of Objective

There was no change in project activities and their objectives, except that we agreed to reschedule the timing of these activities based on the availability of the 2 Japanese resource persons.

- Training Workshop on Diagnostics of Plant Parasitic Nematodes
 This training workshop will be organized at the Applied Research Institute of Agricultural Quarantine (ARIAQ), Ministry of Agriculture, Bekasi, Indonesia, from 23rd February to 7th March 2020. The General Introduction and Program of the training is given in the Attachment 5. We have received all nominations from AMS, i.e. 20 participants (2 participants per member state, see Attachment 6).
- Training Worshop on Begomovirus and LAMP-PCR
 This training workshop will be organized at the National Crop Protection Centre (NCBC),
 University of the Philippines, Los Banos, Philippines from 8-19 June 2020 with Dr. Marita
 Pinili as the Local Coordinator. The General Introduction and Program of the training is given
 in the attachment 7.
- 3. Attachment Program on Plant Parasitic Nematodes
 The attachment program will be organized in July for 2 months.

As the attachment program in Japan will only be completed in the month of August, therefore the Project Steering Committee members has agreed that APHCN-ASEANET should submit official request to ASEC and JMT for 3-months, no-cost extension from 14th July 2020 to 15th October.
